## PERFORMANCE CONTRACT

**Retainer** - A non-refundable deposit of \$\_\_\_\_ and a signed contract must be secured prior to any services performed by Magician. This is non-refundable because this date and time is being reserved for you.

**Balance** to be paid no later than one week prior to event. Magician will remind Client.

**Payments** accepted through Venmo (@kujmagic), last 4 digits of phone number 2910 (if Venmo asks), PayPal (kujawabc@gmail.com), or Credit Card (www.kujmagic.com/pay).

**Cancellation Policy** - If the event is cancelled by the client less than 2 weeks before date, final payment will be required to compensate for hours of preparation and turning down other work for this performance. If Magician cancels due to illness or unforeseen circumstance, the full balance will be refunded to the Client. Please note the deposit is non-refundable.

**Postponement Policy** - If the event is postponed, due to unforeseen circumstances, such as inclement weather, Magician will work directly with Client to find a new date.

**Responsibility** - Magician is not responsible for Acts of God, Natural Disasters, an Act of Government such as A Declaration of National or Local Emergency, or Other Incidents Not within the control of the magician, i.e. accident, death in the family, illness, pregnancy, or sudden tragic circumstance.

**Overtime** - Additional unplanned and/or un-contracted services are considered overtime and will be billed with prior notification and consent at the rate of \$\_\_ per hour.
